The Position: A Snapshot

The Orange County Department of Health seeks a knowledgeable forensic pathologist to serve as Deputy Medical Examiner, working under the Medical Examiner and operating with independent judgment day-to-day.

The Deputy Medical Examiner is a competent and tactful practitioner responsible for investigating sudden, unexpected, and unnatural deaths, conducting complicated autopsies, analyzing test results, reporting and record keeping, and supervising staff. They are part of a eight-person team comprised of two medical doctors and six professional, technical, and support staff members; the group also works closely with private contractors who are hired as investigators.

The Organization

Orange County is currently led by County Executive Steven M. Neuhaus; a key focus during his tenure in office has been enhancing the County's public health and safety. The Department of Health aims to monitor, protect, and promote public health for all citizens of Orange County. The Office of the Medical Examiner is a key piece of that work. This position reports to Dr. Jennifer Roman, the Medical Examiner. While the work itself is serious, the team has a strong rapport and enjoys working alongside one another.



A Day in the Life of the Deputy Medical Examiner

As Deputy Medical Examiner, your days will be filled with a variety of duties and responsibilities. On any given day, you could find yourself:

- Investigating the cause and manner of any death in Orange County that is unnatural, sudden, or unexpected.
- Performing autopsies, external examinations, and medical record reviews, evaluating findings, analyzing data, and documenting results.
- Remotely supervising visitations of death scenes via phone communication with on-scene investigators.
- Working in harmony with medical professionals, hospitals, law enforcement agencies, the District Attorney's office, funeral homes, etc.
- Certifying death certificates electronically in the NYS Database Application Vital Events (DAVE) via the NYS Health Commerce System (HCS).
- Preparing reports and maintaining records in accordance with regulations.
- Delivering relevant records to the District Attorney when necessary.
- Testifying in court.
- Supervising and/or training professional and technical staff, overseeing contracted staff.

The position allows for good work-life balance and involves handling a caseload translating to less than 250 autopsies per year per physician.
